**1992-01** AN ORDINANCE TO ESTABLISH RECORDS COMMISSION FOR THE VILLAGE OF BUCKEYE LAKE, LICKING COUNTY, OHIO AND DECLARING AN EMERGENCY.

**1992-02** AN ORDINANCE TO ADOPT THE 1992 REPLACEMENT PAGES FOR THE MODEL OHIO MUNICIPAL CODE PUBLISHED BY THE JUSTINIAN PUBLISHING COMPANY; TO REPEAL ORDINANCES IN CONFLICT THEREWITH AND TO DECLARE AN EMERGENCY.

**1992-03** ANNUAL APPROPRIATION ORDINANCE.

**1992-04** **TABLED** - AN ORDINANCE TO ESTABLISH A VILLAGE TREE COMMISSION TO PROMOTE, PROTECT AND PRESERVE THE PLANTING AND DEVELOPMENT OF TREES IN THE VILLAGE OF BUCKEYE LAKE; AUTHORIZING THE MAYOR TO MAKE APPOINTMENTS THERETO AND DEFINING THE RESPONSIBILITIES AND POWERS THEREOF.

**1992-05** AN ORDINANCE TO INCREASE THE COMPENSATION TO BE PAID THE CLERK- TREASURER OF THE VILLAGE OF BUCKEYE LAKE, LICKING COUNTY, OHIO AND TO THE CLERK OF THE MAYOR'S COURT OF THE VILLAGE OF BUCKEYE LAKE, OHIO.

**1992-06** AN ORDINANCE TO ESTABLISH A VILLAGE TREE COMMISSION TO PROMOTE, PROTECT AND PRESERVE THE PLANTING AND DEVELOPMENT OF TREES IN THE VILLAGE OF BUCKEYE LAKE; AUTHORIZING THE MAYOR TO MAKE APPOINTMENTS THERETO AND DEFINING THE RESPONSIBILITIES AND POWERS THEREOF AND DECLARING AN EMERGENCY.

**1992-07** AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$8,000 OF NOTES BY THE VILLAGE OF BUCKEYE LAKE, OHIO, IN ANTICIPATION OF THE ISSUANCE OF BONDS FOR THE PURPOSE OF PAYING PART OF THE COST OF ACQUIRING A BUILDING WHICH WILL BE USED FOR MUNICIPAL OFFICES IN THE VILLAGE, AND DECLARING AN EMERGENCY.

**1992-08** AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$47,000 OF NOTES BY THE VILLAGE OF BUCKEYE LAKE, OHIO, IN ANTICIPATION OF THE ISSUANCE OF BONDS FOR THE PURPOSE OF PAYING PART OF THE COST OF ACQUIRING A BUILDING WHICH WILL BE USED FOR MUNICIPAL OFFICES FOR THE VILLAGE, AND DECLARING AN EMERGENCY.
