- 2007-06** AN ORDINANCE ANNEXING CERTAIN TERRITORY, GENERALLY DESCRIBED AS BEING APPROXIMATELY 2.122 ACRES LOCATED ON THE CORNER OF HUNTS LANDING ROAD AND LYNN STREET, CURRENTLY IN LICKING TOWNSHIP.
- 2007-07** AN ORDINANCE DESIGNATING ONE WAY TRAFFIC ON A SECTION OF PARK STREET WITHIN THE VILLAGE OF BUCKEYE LAKE, LICKING COUNTY, OHIO.
- 2007-08** AN ORDINANCE CHANGING THE ZONING CLASSIFICATION OF CERTAIN REAL PROPERTY, GENERALLY DESCRIBED AS BEING APPROXIMATELY A 64.88 ACRE +/- PARCEL LOCATED ON HUNTS LANDING ROAD IN LICKING COUNTY.

- 2007-13** AN ORDINANCE AUTHORIZING THE PURCHASE OF A .973 ACRE, MORE OR LESS, PARCEL OF LAND FROM MRS. NEEL, LOCATED ON RT. 79, VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING, STATE OF OHIO.
- 2007-14** AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH JOBES, HENDERSON & ASSOCIATES, INC. FOR ENGINEERING SERVICES RELATED TO THE WALNUT ROAD SIDEWALK PROJECT GRANT, AND DECLARING AN EMERGENCY.
