

2014 RESOLUTIONS INDEX

- 2014-01** A RESOLUTION REQUESTING THAT THE LICKING COUNTY BOARD OF ELECTIONS RE-ESTABLISH A POLLING PLACE WITHIN THE VILLAGE OF BUCKEYE LAKE AND DECLARING AN EMERGENCY.
- 2014-02** A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT WITH LICKING TOWNSHIP TO PROVIDE EMERGENCY MEDICAL SERVICES FOR MAPLE BAY AND HUNTS LANDING AREA RESIDENTS OF LICKING TOWNSHIP AND DECLARING AN EMERGENCY.
- 2014-03** A RESOLUTION FOR THE VILLAGE OF BUCKEYE LAKE TO JOIN WITH LICKING COUNTY AND OTHER MUNICIPAL ENTITIES IN THE COUNTY TO RE-ADOPT THE COUNTYWIDE ALL-NATURAL HAZARD MITIGATION PLAN (CANHMP).
- 2014-04** RESOLUTION DECLARING NECESSITY FOR A RENEWAL TAX LEVY IN EXCESS OF THE TEN-MILL LIMITATION, AND REQUESTING THE LICKING COUNTY AUDITOR TO CERTIFY THE TOTAL CURRENT TAX VALUATION AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY THIS NEW LEVY, PURSUANT TO SECTIONS 5705.03, 5705.192, 5705.25 OF THE OHIO REVISED CODE AND DECLARING AN EMERGENCY.
- 2014-05** A RESOLUTION FORMERLY REQUESTING THAT THE COUNTY PAY THE VILLAGE OF BUCKEYE LAKE APPROXIMATELY .8 MILLS OF TAX REVENUE FORMERLY PAID BY RESIDENTS OF THE VILLAGE OF BUCKEYE LAKE TO UNION TOWNSHIP.
- 2014-06** A RESOLUTION AUTHORIZING THE MAYOR AND CLERK TO PLACE A RENEWAL GENERAL FUND LEVY IN EXCESS OF THE TEN (10) MILL LIMITATION ON THE BALLOT AND DECLARING AN EMERGENCY.
- 2014-07** RESOLUTION DECLARING NECESSITY FOR THE RENEWAL OF AN EXISTING TAX LEVY IN EXCESS OF THE TEN-MILL LIMITATION, AND REQUESTING THE LICKING COUNTY AUDITOR TO CERTIFY THE TOTAL CURRENT TAX VALUATION AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY THAT RENEWAL LEVY, PURSUANT TO SECTIONS 5705.03, 5705.192, 5705.25 OF THE OHIO REVISED CODE AND DECLARING AN EMERGENCY.

- 2014-08** A RESOLUTION AUTHORIZING THE MAYOR AND CLERK TO PLACE A RENEWAL POLICE LEVY IN EXCESS OF THE TEN (10) MILL LIMITATION ON THE BALLOT AND DECLARING AN EMERGENCY.
- 2014-09** A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR.
- 2014-10** A RESOLUTION APPROVING THE JOINING OF OPEC-HC, APPROVING THE AGREEMENT WITH OPEC-HC AND APPOINTING A VILLAGE REPRESENTATIVE.
