<u>Community Development Committee:</u> Meeting held tonight where they discussed some things related to short-term rentals. Had some good debate and discussion. Will need another meeting before bringing anything to full council.

<u>Personnel Committee:</u> Nothing new since last meeting. Next Personnel meeting will follow Finance Committee meeting on July 14<sup>th</sup> with further discussion on the agreement with the company to possibly do the payment study. She hopes Finance Committee will also have a discussion to get it into the next budget cycle.

## REPORT OF VILLAGE OFFICIALS - WRITTEN OR VERBAL

<u>Police Department – Chief Jason Harget:</u> Black and white cruiser engine seized up. This was the old K-9 cruiser. Have gotten almost 5 years-worth of use from it. Paid \$10,000 for it. It is at its end of life. Took it to Goodyear as it was using more oil than usual. Would have to put a whole new engine in it and it's not worth it. 3 quotes – over \$60,000 for a new

cruiser. \$43,000 for a gently used vehicle that has been in an accident and has 1,100 miles on it. If approved, 5<sup>th</sup> vehicle Chief will have purchased from this company. Already equipped with lights and sirens. One year warranty. 2023. Will discuss this in new business. \$180,000 in public safety capital line which was started in order to not have to take loans out on vehicles. They will not hold this deal and vehicle. Looking to do a floor vote with discussion under New Business.

Fire Department – Interim Chief Jerry Brooks: 60 runs in May, 13 Fire, 47 EMS, 8 mutual aid. EMS 26 transports. Garage door opener went out, has been ordered. Had hose and ladder testing. Some hose will need replaced. Batteries delivered for portable radios. One mobile radio failed. Still working on getting credit application with tire company to get engine back on the road. Trying to participate with Water's Edge on Wednesday nights and helping with the Summer Lunches. Team is doing training on Worth Drive. Summer intern at the office is looking for and working on grants for power cot purchase. \$168,000 in public safety capital that is to be split between Police and Fire. Currently paying for the medic out of that fund for Fire. \$36,000 in the Fall will be paid out of that. Been in contact with other chiefs about BLASST event. They will be running two medic crews and a full engine crew and will cover all of North Bank. Staffing is great. Two medics waiting to go through the process.

Public Works - Superintendent Toby Miller: Absent, no report.

Parks and Recreation - Annetta Macedonia: Representative absent. Meeting minutes submitted.

<u>Code Enforcement – Rex Adkins</u>: Code enforcement and short-term rental reports submitted. If anyone has any issues with short-term rentals, please call the office so he can note them on the system.

**Zoning – Kevin Strang:** Absent. Report submitted.

Planning / Zoning / BZA Commissions: No representatives. No reports. Zoning meeting Thursday night.

Report of Mayor Goodman: July 1st 10am ribbon cutting for new transit bus route. Signs are up for where the stops will be. Summer Lunch program is in full swing. Fire department will spray the kids off some days. Keeping our outside crews hydrated. BLASST for Kids Cookout event on July 3rd 11-2pm as part of the Summer Lunch program. Thanked the sponsors this year. Mayor has received an inquiry from the brewery about whether the village is interested in leasing or selling the drive-thru building next door. Licking County Library will vacate their Buckeye Lake location on August 30th. They will be moving things out during September. Friends of the Buckeye Lake Library will take the Buckeye Lake location and will operate it as a Greater Buckeye Lake Learning Center where they will offer learning opportunities and programming with a lot of other possibilities. BLASST fireworks on July 3rd 9:45pm. Public Safety meeting for BLASST will be at the Rec Center on June 30th. The strongest communities are not the wealthiest ones. The strongest communities are the ones where people check on their neighbors, share what they have, understand that "we" matters more than "me" or "I". We are getting better and trying harder and it takes all of the families and businesses and organizations to be a part of a better place to live and work and play. **Discussion:** Councilor Cable has been asking for information regarding proposed income tax values and information about levies vs income tax. RITA has provided numbers from comp municipalities all based on 1% income tax. Councilor Cable researched the municipalities further, finding out number of households and other information on industries. Levies and property for the village currently bring in approximately \$1.5million. When police levy gets rolling, it will go up to \$1.9million. Is \$1.5million high enough or too low to replace or subsidize the levy system? Councilor Cable stated that we cannot continue to go to the voters every year when a levy is up. Mayor Goodman stated that those communities that have 1%, almost all have it automatically per ORC without having to go to the voters but because of the way our Charter is written, it prevents us from doing that. There is so much legislation being proposed at the State level. They are looking at doing a flat 2.75% flat rate income tax but it has not happened yet.
