

ORDINANCE NO. 2003-02  
VILLAGE OF BUCKEYE LAKE, OHIO

AN ORDINANCE TO ENTER INTO A CONTRACT TO PURCHASE OF A 1996 CHEVY TAHOE

**WHEREAS**, the Village of Buckeye Lake, Licking County, Ohio, needs to secure a vehicle for its police department;

**WHEREAS**, there is currently available to purchase a 1996 Chevy Tahoe, VIN: 1GNEK13R3TJ386015, which has been claimed by and is under the ownership and control of All State Insurance;

**WHEREAS**, it is desire of All State Insurance to sell this vehicle to the Village of Buckeye Lake at a reasonable price, to wit: \$6,770.97;

**WHEREAS**, there are sufficient funds available in the general fund for such purpose; and

**WHEREAS**, it is necessary for the public health, safety, welfare and morals of the Village that this Ordinance be adopted immediately without delay.

**NOW THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE AUTHORITY OF THE VILLAGE OF BUCKEYE LAKE:**

Section 1. That Chief of Police, Mayor and Clerk are hereby authorized to take all steps reasonable and necessary to secure the purchase from All State Insurance of the said 1996 Chevy Tahoe, VIN: 1GNEK13R3TJ386015, and to cause the license, title and registration therefor to be transferred into the name of the Village of Buckeye Lake;

Section 2. That the Chief of Police, Mayor and Clerk further take all steps reasonable and necessary to secure insurance coverage for said vehicle prior to is use by any person or official associated with the Village of Buckeye Lake;

Section 3. Council declares this to be an emergency measure immediately necessary for the preservation of the public health, safety, welfare, and morals, such emergency arising out of the necessity to provide for the continued and effective operation of the Village government without the due delay and in order to correct a situation now deemed undesirable; wherefore this ordinance shall take effect and be in force from and after its passage and approval by the Mayor.

Section 4. Each section and each part of each section of this Ordinance is hereby declared to be an independent section or part of a section and, notwithstanding any other evidence of legislative intent, it is hereby declared to be the controlling legislative intent that if any such section or part of a section, or any provision thereof, or the application thereof to any person or circumstances, is held to be invalid, the remaining sections or parts of sections and the application of such provision to any other person or circumstances, other than those to which it is held invalid, shall not be affected thereby, and it is further declared to be the legislative intent that the other provisions of this Ordinance would have been adopted independently of such section, sections or parts of a section so held to be invalid.
